MEMORANDUM IN SUPPORT OF
MOTION OF MINNESOTA
COMMISSIONER OF PUBLIC SAFETY
FOR ASSIGNMENT OF IMPLIED
CONSENT CASES TO A SINGLE JUDGE
OR PANEL OF JUDGES

INTRODUCTION

In accordance with Rule 113.03 of the Minnesota Rules of General Practice and the inherent authority of the Court, the Minnesota Commissioner of Public Safety, Michael Campion, requests assignment to a single judge, or a panel of judges, of all pending implied consent cases in the State involving Intoxilyzer 5000EN source code challenges. Such assignment is appropriate because the cases involve common questions of fact and have a special need for coordinated judicial management.

ARGUMENT

**THE CHIEF JUSTICE SHOULD ASSIGN ALL IMPLIED CONSENT CASES CHALLENGING THE
INTOXILYZER 5000EN SOURCE CODE TO A SINGLE JUDGE OR JUDICIAL PANEL.**

Minnesota Rule of General Practice 113.03 provides as follows:

When two or more cases pending in more than one judicial district involve one or more *common questions of fact* or are otherwise related cases in which there is a special need for or desirability of central or *coordinated judicial management*, a motion by a party or a court's request for assignment of the cases to a single judge may be made to the chief justice of the supreme court.

(Emphasis added). The authority of the Chief Justice of the Minnesota Supreme Court to make such an assignment is derived from the Court's inherent power and statutory recognition of that power. Rule 113.03, Advisory Committee Comment - 2000 Amendments Rule 113.03 was

adopted to provide a formal procedure for requesting assignment of multiple cases to a single judge. *Id.* The Rule is intended to serve the same purpose as the federal process relating to multidistrict litigation. *Id.* As the Comment to Rule 113.03 states:

Although this rule is not as complex as its federal counterpart, its purpose is largely the same -- *to facilitate the efficient and fair handling of multiple cases.* Practice under the federal statute has worked well, and is one of the most important tools of complex case management in the federal courts.

(Emphasis added; citation omitted).

The Chief Justice has used this authority of assignment in a variety of cases to facilitate the efficient administration of justice. *See, e.g., In re Continental Casualty Co.*, 749 N.W.2d 797, 800-02 (Minn. 2008); *In re LaSalle Bank/Twin Cities Avanti Stores Litig.*, 654 N.W.2d 103 (Minn. 2002); *Minnesotans for Responsible Recreation v. Department of Natural Resources*, 632 N.W.2d 534 (Minn. 2001); *Kilbourne v. Project Net, Inc.*, 633 N.W.2d 850 (Minn. 2001); *In re Twin Cities Harley-Davidson Litig.*, 622 N.W.2d 549 (Minn. 2001); *In re Vitamin Antitrust Litig.*, 606 N.W.2d 446 (Minn. 2000); *In re Minnesota Silicone Implant Litig.*, 503 N.W.2d 472 (Minn. 1993); *In re Minnesota Personal Injury Asbestos Cases*, 481 N.W.2d 24, 25-26 (Minn. 1992). Assignment to a single judge or panel of judges of all pending implied consent cases in the State involving Intoxilyzer 5000EN source code challenges is appropriate because both grounds justifying assignment under Rule 113.03 are satisfied

A. The Implied Consent Cases Asserting Challenges To The Source Code Involve Common Issues Of Fact.

All pending implied consent cases involving source code challenges raise common questions of fact. These cases include petitioners who, under the State's Implied Consent Law, submitted to a breath test using the Intoxilyzer 5000EN and received an alcohol concentration test result of 0.08 or more. *See* Affidavit of Emerald Gratz ("Gratz Aff") ¶¶ 2-4. In each of these implied consent cases, the petitioner has challenged the reliability of his or her Intoxilyzer

5000EN test result based on a belief that reviewing the source code for the Intoxilyzer 5000EN may reveal a material defect affecting the instrument's ability to produce accurate alcohol concentration results. See Gratz Aff. ¶ 4. Pursuant to precedent set by the Court in *State v Underdahl/Brunner*, 767 N.W.2d 677 (Minn. 2009) (*Underdahl II*), district court judges have granted, and are continuing to grant, petitioners' discovery motions requesting access to the source code for review and analysis by an expert witness. See Gratz Aff. ¶¶ 3-5. Defense counsel in all of these cases have sought and obtained access to the source code with the intent to prove that the source code is materially defective. See Gratz Aff. ¶ 4. Accordingly, all of the pending implied consent cases that raise challenges to the source code involve common questions of fact, including whether a material defect exists in the source code.

B. The Implied Consent Cases Involving Source Code Challenges Have A Special Need For Coordinated Judicial Management.

These cases also have a special need for coordinated judicial management. This is due to the potential for inconsistent rulings and the inefficient use of judicial resources. See, e.g., *In re Twin Cities Harley-Davidson Litig.*, 622 N.W.2d at 550; *In re Minnesota Vitamin Antitrust Litig.*, 606 N.W.2d at 446. Currently, there are approximately 717 pending implied consent cases involving Intoxilyzer 5000EN source code challenges in all 10 judicial districts in the State of Minnesota. See Gratz Aff. ¶ 6. The potential for inconsistent rulings regarding the same issue raised in 717 cases is apparent. The judicial inefficiency of litigating and adjudicating the same issue up to 717 times is similarly clear.

Individual district court judges are hearing and deciding, for example, the identical discovery motions or requests for continuance, and they all may be called upon to decide whether a material defect exists in the source code. See Gratz Aff. ¶ 5. The sheer volume of these cases is taxing already strained judicial resources. Some judicial districts have attempted

to designate a particular judge within the district to oversee the district's cases, while others have not attempted any such consolidation. *See id.*, ¶ 5. In districts that have designated a particular judge, the filing of notices to remove the judge can complicate the district's efforts. *See, e.g., id.* A group of some petitioners' counsel is coordinating efforts, but across the ten judicial districts of the State and before various different judges. *See Gratz Aff.* ¶ 4. There is a real and immediate need for *statewide* coordination of these cases. Application of Rule 113.03 would provide for that coordination and "facilitate the efficient and fair handling of multiple cases" as contemplated by the Rule. Rule 113.03, Advisory Committee Comment, *supra*. Moreover, a judge assigned to a case by the Chief Justice can only be removed for cause. *See id.*, Minn. R. Civ. P. 63.03.

Assignment pursuant to Rule 113.03 will allow a single judge or panel to efficiently coordinate this litigation on a statewide basis. The judge or panel should:

- (1) Establish a timetable for a defense counsel expert to examine the source code and issue a report should the expert determine that a material defect exists in the source code;
- (2) If the defense expert issues a report identifying an alleged material defect in the source code, establish a timetable for the Commissioner's expert to examine the source code and issue a rebuttal report in response; and
- (3) If an evidentiary hearing is necessary to determine whether a material defect exists in the source code, preside over such a hearing and establish necessary timetables and procedures.

In addition, as Rule 113.03 contemplates, the assigned judge or panel could consider and implement methods used in multidistrict litigation in the federal courts to, for example, coordinate the litigation efforts of all counsel. *See Manual for Complex Litigation*, Fourth (2004).

All currently pending implied consent cases to be assigned to a single judge or judicial panel are listed in the attachment to the Affidavit of Emerald Gratz indicating, as required by Rule 113.03(b), the court, case title, and case number.¹ Also pursuant to Rule 113.03, counsel for petitioners in all of these cases, and one unrepresented petitioner, have been served with the Commissioner's motion. Most counsel represent multiple clients who raise challenges to the source code; a total of approximately 140 lawyers represent the 717 petitioners (with the exception of the one *pro se* petitioner). See Gratz Aff ¶ 6.

The Commissioner also notes in accordance with Rule 113.03(b) that he anticipates a substantial number of additional implied consent cases challenging the source code will continue to be filed in the future. The Commissioner requests that any new implied consent cases filed after the date of this motion which raise a challenge to the source code be assigned with the 717 pending cases. The Commissioner would provide an ongoing updated list to the Court and the assigned judge or panel. There may also be requests from counsel for petitioners and prosecutors to have a challenge to the source code raised in a related criminal DWI case to be heard as part of the statewide proceeding. The Commissioner has no objection to such requests.

¹ No "assigned" judge is designated on the attachment because implied consent cases are not typically assigned or blocked to a specific district court judge in the county or district. Instead, a judge is assigned to hear the merits of an enumerated list of implied consent cases set for a specific day. That assignment usually is made shortly before the hearing date. The official court docket therefore does not designate an assigned judge, even in the districts where there has been some attempt to consolidate with a particular judge the implied consent cases involving source code challenges. See Gratz Aff ¶ 7.


CONCLUSION



review. The majority of individuals arrested for DWI who fail an Intoxilyzer 5000EN breath test and petition the district court for judicial review under the Implied Consent Law request discovery of the source code for the Intoxilyzer 5000EN. These discovery requests are premised on a challenge to the reliability of the individual's Intoxilyzer 5000EN test result. In accordance with *State v. Underdahl/Brunner*, 767 N.W.2d 677 (Minn. 2009) (*Underdahl II*), district court judges have granted, and are continuing to grant, these discovery requests for access to the Intoxilyzer 5000EN source code.

4. Petitioners' counsel in all of these cases have sought and obtained access to the source code with the intent to prove that the Intoxilyzer 5000EN source code is materially defective and therefore the testing instrument does not produce accurate alcohol concentration results. A large number of private defense counsel and public defenders have formed a working association (known as the "Source Code Coalition") to coordinate their efforts in retaining an expert witness(es) to review the source code and then challenge the reliability of the Intoxilyzer 5000EN in court.
5. Individual district court judges in all ten judicial districts across the State are hearing and deciding identical source code discovery motions as well as requests for continuances, and may be called upon to decide whether a material defect exists in the source code. Some judicial districts have designated a particular judge to oversee the district's cases, while others have not attempted any such consolidation. The filing of a notice to remove the judge pursuant to Minn. R. Civ. P. 63 would require the designation of a "back-up" judge or judges within the district.
6. Currently, there are approximately 717 pending implied consent cases involving Intoxilyzer 5000EN source code challenges in all 10 judicial districts in the State of

Minnesota. In accordance with Minnesota Rule of General Practice 113.03(b), attached as Exhibit A is a list of all the currently pending implied consent cases involving Intoxilyzer 5000EN source code challenges. Most defense counsel represent multiple petitioners; a total of approximately 143 lawyers represent the 717 petitioners (with the exception of the one *pro se* petitioner). It is anticipated that a substantial number of additional implied consent cases challenging the source code will continue to be filed in the future.

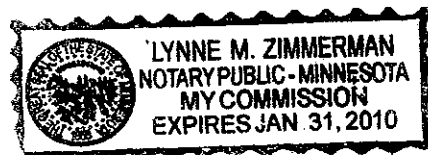
7. Implied consent cases are not typically assigned or blocked to a specific district court judge in the county or district. Instead, a designated judge is assigned shortly before the trial date to hear the merits of an enumerated list of implied consent cases set for court trials on a specific day. Therefore, the official court docket does not designate an assigned judge, even in the districts where there has been some attempt to consolidate the implied consent cases involving source code challenges with a particular judge.
